As an enterprise fund, SVMD must generate enough revenue to cover its operating costs. An increase is necessary to continue to deliver safe, reliable drinking water to more than 10,000 people. Keeping water affordable while meeting the challenge of maintaining an efficient and reliable water system poses a significant challenge for SVMD and the service community. Our long range water plan integrates both water resource and water management planning with infrastructure planning, repair, maintenance and construction. Even though we continue to conserve more water, expenses to maintain the water system continue to rise.
