- 2. SVMD Landscape Report. Charlie Wenger/SVMD Landscape Manager gave a brief overview of the report to the Board. Mr. Wenger informed the Board that the old caulking and tile around the pool needs to be replaced. The work will be completed in April of 2025. Mr. Wenger informed the Board that all remaining irrigation controllers will be installed by March 2025.
- 3. SVMD Prep and Re-Stain of Existing Fences. The Board reviewed the proposal from Commercial Fence & Iron. The Board noted that it had sought additional proposals from contractors to re-stain the fencing, but contractors were unwilling to commit to the scope of work, which required that a three-man crew be dedicated to the project on a continuous basis until project completion. The Board reviewed and approved the proposal to prep and stain existing District owned and maintained, 6ft and 4ft privacy fences, in SVMD, for Phase 1 (6' \$113,186.00) and 6' Phase 2 (\$93,110 and \$82,999).

RESOLVED by general consent: The proposal Commercial Fence & Iron, is approved.

- 4. System Access Fee Increase 2024 for Compark Metropolitan District. District Manager Plummer gave an overview of the 1.893% increase for the system access fee for Compark Metropolitan District. The Board reviewed the increase. RESOLVED by general consent: The System Access Fee increase, is approved.
